What is the Wellness Benefit?

The Wellness Benefit provides an annual benefit payment if you complete a health screening test, whether or not there is any out-of-pocket cost to you. You only need to complete one health screening test, and may only receive a benefit payment once per year, even if you complete multiple health screening tests. You may also receive a benefit payment for your spouse and/or children if they are covered for the Wellness Benefit and complete a health screening test.

How can the Wellness Benefit help?

More is learned every day about the importance of regular health screenings and the increased chances of survival when serious illnesses are detected early. The Wellness Benefit encourages you to get regular health screenings. The benefit payment you receive for your health screening can be used to help pay for the cost of the test or however you like.

What types of health screening tests are eligible?

Health screening tests include but are not limited to:

- Blood test for triglycerides
- Chest x-ray
- Biometric screenings
- Pap smear or thin prep pap test;
- Mammography
- Electrocardiogram (EKG)
- Flexible sigmoidoscopy
- Colonoscopy
- Annual Physical Exam – Adults
- CEA (blood test for colon cancer)
- CA 15-3 (breast cancer)
- CA 125 (ovarian cancer)
- Bone marrow testing
- Stress test on bicycle or treadmill
- Tests for sexually transmitted infections (STIs)
- Serum cholesterol test for HDL & LDL levels
- Fasting blood glucose test
- Ultrasound screening for abdominal aortic aneurysms
- Hemocult stool analysis
- Thermography
- Hemoglobin A1C (HbA1c)
- Serum Protein Electrophoresis (myeloma)
- PSA (prostate cancer)
- Bone density screening
- Breast ultrasound, sonogram, MRI
- Hearing test
- COVID19 test
- Routine eye exam
- Routine dental exam
- Well child/preventative exams through age 18

How much does it cost?

The Wellness Benefit is automatically included with your coverage at no additional cost to you.

How much is the Wellness Benefit?

Your employer's plan specifies the benefit amount payable for each person who completes a health screening test. In many cases, you will be eligible for an annual benefit of \$50 for yourself and your spouse, and \$25 for any covered child, with a maximum of \$100 in child benefits per calendar year.

Our insurance products pay a fixed benefit amount upon the occurrence of specified events that occur on or after the insured person's coverage effective date. These are not health insurance and do not satisfy the requirement of minimum essential coverage under the Affordable Care Act.
