## At [meritain.com](http://meritain.com), you can:

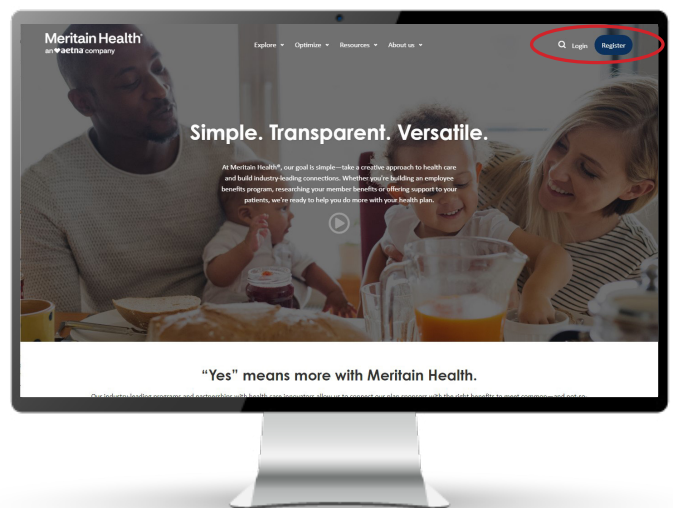
- Check your benefits and eligibility.

## Access is as easy as 1-2-3

If you already have an account, you can simply log in. But if you're a new user, you'll need to register with these simple steps. When you're registering, you can use the last four digits of your Social Security number (SSN) to help identify you or you'll need your member ID and group ID from your ID card. If you're new to the plan, you'll receive your ID card in the mail soon.

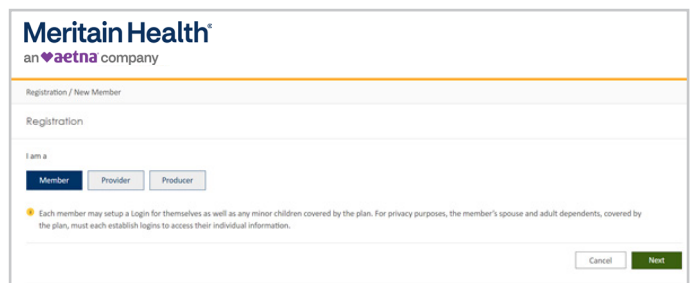
### Step 1

Scan the QR code and click on the link to register or visit [www.meritain.com](http://www.meritain.com) and click *Register*.



### Step 2

Select *Member* under *I am a*. Then, click *Next*.




## Step 3

Register with your member ID number or the last four digits of your SSN. You'll need to enter the following information, then select **Submit**:

- Member ID and group ID from your member ID card or SSN
- First name (employee, spouse or adult dependent)
- Last name (employee, spouse or adult dependent)
- ZIP code
- Personal email address
- Date of birth (mm/dd/yyyy)



Then, create a username and password. After you confirm your email address—you're done!

You can now log in to your account with your new username and password.

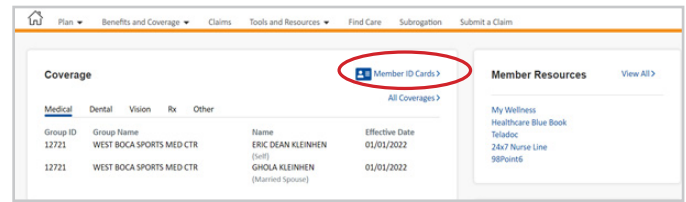

Click *Home* whenever you'd like to return to the homepage.

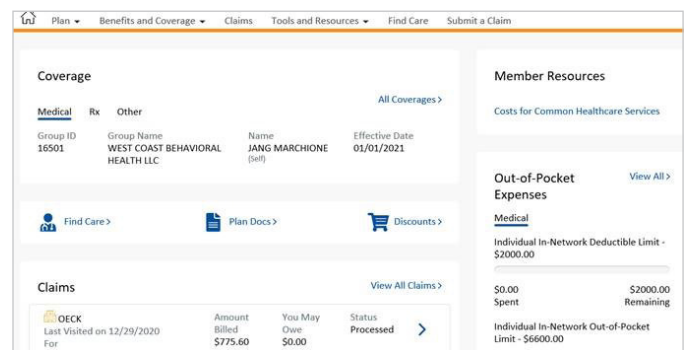
## Member ID card

Simply click on the *Member ID Card* icon in the coverage box—you will be able to easily access a copy of your ID card! You can also download a copy of your digital ID card.




## Health care plan overview

## Claim information

Click *Claims* to view your claim information. The *Apply* button lets you view all claims. You'll see claims with statuses of *In Process*, *Processed* or *Awaiting Review*. You can view and print the Explanation of Benefits (EOBs) by clicking for the claim details under the claim number.

## Important information about the member website

### Spouses and dependents

Per HIPAA Privacy Regulations, spouses and dependents over age 18 have partially protected health care information. To access their information, they'll need to register for their account using the previous steps. You can view financial information for all dependents, regardless of age.

### Returning user login

When returning to the website after your account has been created, simply enter your established username and password in the login box.

### Incorrect login

If you receive an incorrect login message, you can click *Home* to return to the homepage and try again.



### Website support
